1. NAME OF THE GAME

- 1.1. The game of Sic Bo shall be played at a table having on one side an area for the players and on the opposite side an area for the dealer/s.
- 1.2. The tables will have:
 - 1.2.1. Playing areas designated for the placement of wagers;
 - 1.2.2. The name and/or logo of the casino imprinted thereon.

2. **DEFINITIONS**


In these rules, unless the contrary intention appears:

- 2.1. "Round of play" means the period of play commencing with the announcement of no more bets and ending once the result has been determined and all winning wagers paid;
- 2.2. "Dice Tumbler" an electronic or manual device used to shake/tumble the dice.

3. TABLE LAYOUT AND EQUIPMENT

3.1. The layout shall be marked in a manner similar to that shown in diagram "A":

3.2. The Table shall be fitted with electronic equipment. When the three winning numbers corresponding to the uppermost faces of the winning dice are entered, all winning areas of the layout shall be illuminated:



3.3. A dice tumbler, used to tumble the dice is either mechanically or electronically activated, affixed to the table and will be dome-shaped with a removable, non-transparent cover:



3.4. A set of three dice are sealed in the dice tumbler. The sides of each die shall be numbered with dots from one to six, so arranged that the sum of the numbers of any pair of opposite sides on each die is seven:



3.5. An entry terminal, linked to the electronic equipment, shall be attached to the top of the table and have switches or buttons numbered 1, 2, 3, 4, 5 and 6:



3.6. The table may be fitted with electronic equipment which is programmed to record the result of each shake of the dice and display the most recent results on the table:



3.7. The table shall have a drop box/tip box attached to it:

3.8. The table shall have drop box Plunger:



3.9. UV light scanner that is used to scan cash or chips if there is any suspicion the cash/chips are counterfeit:

4. HOW TO PLAY

- 4.1. Wagers shall not be placed otherwise than by means of chips on the appropriate areas of the table and within the clearly marked sectors.
- 4.2. Orally declared wagers will not be accepted unless accompanied with chips and the Dealer has enough time to place the wager on the layout prior to calling "no more bets".
- 4.3. A player is responsible for the correct positioning of their wager on the layout of the Sic Bo table:
 - 4.3.1. All wagers shall be made by placing value chips on the appropriate wagering areas of the layout;
 - 4.3.2. Players are responsible for wager placement when assisted by the dealer and must ensure that any instructions given to the dealer are carried out correctly.
- 4.4. A wager cannot be withdrawn, placed or changed after the dealer has called "no more bets".



- 4.5. Wagers shall be settled in strictly in accordance with the position of chips on the layout after the cover of the dice tumbler is removed and the die exposed.
- 4.6. The dealer at a Sic Bo table shall determine the status of any wager and pay any wager in strict accordance with its position on the table layout.
- 4.7. Enter the result by depressing the buttons on the terminal that correspond with the winning dice.
- 4.8. When the sequence is complete and the winning areas have been illuminated the dealer shall:
 - 4.8.1. Collect all losing wagers from the sections that are not illuminated;
 - 4.8.2. Pay all winning wagers on the sections that are illuminated.

5. PAYOUT ODDS

5.1. The following available wagers at the game of Sic-Bo shall be paid at the odds listed below:

Small	1 to 1
Big	1 to 1
Specific Triple	150 to 1
Specific Double	8 to 1
Any Triple	24 to 1

Three Dice Totals	Odds
4 or 17	50 to 1
5 or 16	18 to 1
6 or 15	14 to 1
7 or 14	12 to 1
8 or 13	8 to 1
9 or 12	6 to 1
10 or 11	6 to 1

1 and 2, 3, 4, 5 or 6	5 to 1
2 and 3, 4, 5 or 6	5 to 1
3 and 4, 5 or 6	5 to 1
4 and 5 or 6	5 to 1
5 and 6	5 to 1

Single Die Wager	1 to 1
Two Dice Wager	2 to 1
Three Dice Wager	3 to 1

6. **DETERMINING THE WINNER:**

- 6.1 "SMALL" means a wager which shall:
 - 6.1.1 Win if any of the totals 4, 5, 6, 7, 8, 9 or 10 appears in any combination of the three dice;
 - 6.1.2 Lose, if any other total or a triple appears.
- 6.2 "BIG" means a wager which shall:
 - 6.2.1 Win if any of the totals 11, 12, 13, 14, 15, 16 or 17 appears in any combination of the three dice;
 - 6.2.2 Lose, if any other total or a triple appears.
- 6.3 "SPECIFIC TRIPLE" means a wager on any one of the specific triples 1, 2, 3, 4, 5, or 6, which shall:
 - 6.3.1 Win if that triple appears;
 - 6.3.2 Lose if any other combination appears.
- 6.4 "SPECIFIC DOUBLE" means a wager on any one of the specific doubles 1, 2, 3, 4, 5 or 6, which shall:
 - 6.4.1 Win if that double or a triple of the same number appears;
 - 6.4.2 Lose if any other combination appears.
- 6.5 "ANY TRIPLE" " means a wager on any triple 1, 2, 3, 4, 5 or 6 which shall:



- 6.5.1 Win if a triple appears;
- 6.5.2 Lose if any other combination appears.
- 6.6 "THREE DICE TOTALS" means a wager on any one of the totals 4, 5, 6,
 - 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 or 17 which shall:
 - 6.6.1 Win if that total appears in any combination of the three dice;
 - 6.6.2 Lose if any other total appears.
- 6.7 "DICE COMBINATIONS "of:
 - a) 1 and 2, 3, 4, 5, or 6;
 - b) 2 and 3, 4, 5, or 6;
 - c) 3 and 4, 5, or 6;
 - d) 4 and 5, or 6;
 - e) 5 and 6.

means a wager on any one of these specific combinations shall:

- 6.7.1 Win if that combination appears;
- 6.7.2 Lose if any other combination appears.
- 6.8 "SINGLE DIE WAGER" wins when that number appears on:
 - 6.8.1. Number on one Die

1 to 1

6.8.2. Number on two Dice

2 to 1

6.8.3. Number on three Dice

3 to 1

7. <u>IRREGULARITIES</u>

- 7.1 In the event of a malfunction of the electronic equipment, the Pit Manager will be notified immediately. The game may continue to be played only after the approval of the Operations Manager.
- 7.2 If the dice do not tumble at least three times after the dice tumbler has been activated the round of play shall be void.
- 7.3 In the event of the concealed dice being exposed before the announcement of "no more bets", the round of play shall be void.



- 7.4 If any of the three dice fail to come to rest with one surface flat to the base of the tumbler, the round of play will be declared void.
- 7.5 When one or more die become damaged, the round of play shall be declared void.
- 7.6 If the glass dome breaks, the round of play shall be declared void.
- 7.7 If the electronic equipment fails to illuminate the winning areas, or fails to illuminate the winning areas correctly, all wagers shall be collected and paid according to the result shown on the dice.
- 7.8 All business decisions beyond the game irregularities are subject to the Director of Table Games or above's decision.

8. <u>HANDLING OF DISPUTES</u>

- 8.1 Any dispute that occurs and cannot be resolved by the D/I or the Pit Supervisor will be escalated to the Pit Manager.
- 8.2 The Pit Manager will gather all relevant information relating to the dispute and inform Surveillance.
- 8.3 Whenever possible give the player a timeframe for trying to settle the dispute.
- 8.4 Resolution of the dispute shall be made with respect to the following:
 - 8.4.1 The approved game rules;
 - 8.4.2 The approved information published by the Casino;
 - 8.4.3 The approved standard operating procedures;
 - 8.4.4 The approved internal control standards;
 - 8.4.5 Accounts of the incident obtained from both parties;
 - 8.4.6 Evidence obtained from Surveillance;
 - 8.4.7 Any other forms of evidence that may be obtained;
 - 8.4.8 Relevant provisions of applicable Vietnam Laws.
- When the player does not agree with the decision of the dispute, they shall be made aware of their rights to file a formal complaint with the Casino's senior management.



8.6 The player shall be guided and receive assistance when filing their formal complaint.
